# Why contract owners may experience tax implications if they have not traded in 2023?

Although contract owners may not have proceeded to any kind of transaction, the *DFS GIF - Canadian Small Cap Equity - NEI* and *DFS GIF – Growth and Income - NEI* hold units of an underlying fund affected by transactions made by the fund manager Northwest & Ethical Investments L.P. (NEI) that have generated taxable dispositions. If units of these guaranteed investment funds (GIF) are allocated to a non-registered contract, a portion of the GIF's capital gain or loss may be allocated to the contract owner. A portion of the capital gains or losses arising from these transactions could be allocated to non-registered contract owners.

# Why are funds managed by Northwest & Ethical Investments L.P. (NEI) have more significant capital gains in 2023?

As part of its investment management, NEI has changed the sub-advisor for the management of the NEI Canadian Small Cap Fund. At the same time, NEI also plan to change the sub-advisor overseeing the Canadian equities held in the NEI Growth and Income Fund.

These changes in sub-advisors have led (or will lead) to changes in the Funds' investment strategy, resulting (or that will result) in transactions on several securities.

# When will these changes be made?

The sub-advisor for the NEI Canadian Small Cap Equity Fund changed on August 1, 2023.

The change of sub-advisor for the NEI Growth & Income Fund is expected to occur on or around November 21, 2023.

# Have these changes had an impact on the DFS GIF funds?

The DFS GIF - Canadian Small Cap Equity - NEI and DFS GIF – Growth and Income - NEI are directly impacted.

# Are the fees paid by contract owners changed?

# Has the investment objective of the DFS GIF - Canadian Small Cap Equity - NEI fund changed?

The change of sub-advisor has not resulted in any change to the investment objective of the DFS GIF - Canadian Small Cap Equity - NEI.



# Has the investment objective of the DFS GIF - Growth and Income - NEI fund changed?

The change of sub-advisor has not resulted in any change to the investment objective of DFS GIF – Growth and Income - NEI.

# Why are there tax implications?

When a sub-advisor changes and its investment strategy differs from that of the previous subadvisor, the new sub-advisor trades portfolio securities to adjust the fund's allocation with its strategy. Where a GIF is composed of units of an underlying fund that has engaged in trading, there may be tax implications for non-registered contract owners who have selected this GIF. This could result, for those contract holders, in capital gains or losses for the year 2023.

# Do we have an estimate of the tax implications by fund?

The following are <u>high-level estimates</u> for the year 2023 of the percentage of capital gain on net assets for each of the DFS GIF funds managed by NEI that are impacted by these changes. These estimates are based on data available as at September 14, 2023, and relate solely to major transactions carried out or anticipated by NEI in connection with sub-advisor replacements for the NEI Canadian Small Cap Fund and the Canadian equity portion of the NEI Growth and Income Fund. Other transactions by NEI during the year may also have generated capital gains and losses for non-registered contract owners.

# Why can't we provide accurate tax impact estimates for each contract owner before the end of the year 2023?

When GIF units are allocated to a non-registered contract, a portion of the GIF's capital gain or loss may be allocated to the contract owner. However, it is difficult to estimate this gain or loss for each contract owner, since the allocation depends in particular on their transactions during the year. Their gains and losses will be communicated to them individually on the tax slips sent out at the beginning of 2024.

There are no tax implications for owners of registered contracts (RRSPs, RRIFs, TFSAs, LIRAs, LIFs, etc.).

Here is a simplified example of a GIF for which the estimated capital gain on net assets would be 5% (estimated capital gains of \$2.5M on total net assets of \$50M) with 5 fictitious clients whose percentage of allocated gains varies from the initial percentage of estimated gains for the fund:
